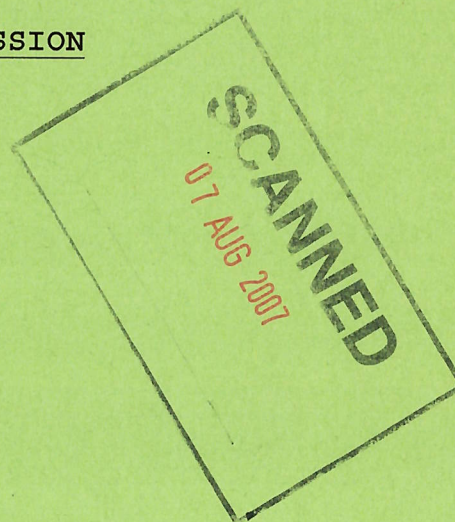



SCHEDULE OF CONDITIONS

1.
 - (a) All farmyard wastes, including slurry and animal manure shall be collected and stored in tanks/pits of minimum capacity of 18 weeks. Silage effluent and soiled water shall be collected and stored in accordance with the EC (Good Agricultural Practice for the Protection of Waters) Regulations, 2006. All agricultural buildings/structures shall be designed and constructed to Department of Agriculture & Food specifications.
 - (b) Soiled yard areas shall be kept to a minimum.
 - (c) All buildings shall be provided with gutters, roof rainwater and clean yard waters shall be discharged of separately in closed pipes to a watercourse or suitable soakpit. All existing and proposed surface water gullies shall be designed to ensure that no polluting matter enters the surface water collection system.
 - (d) All effluent, animal manure's and chemical fertilisers shall be landspread in accordance with EC (Good Agricultural Practice for the Protection of Waters) Regulations, 2006, and in accordance with requirements of the Planning Authority.
 - (e) No change in the approved method of waste disposal and no **increase** in livestock numbers to take place without prior approval in writing from Sligo County Council.
 - (f)
 - (i) The site for the silage base shall be checked for the presence of underground drainage channels, and any field drain or other underground channels found in the vicinity of the silage base to be diverted well away from the site.
 - (ii) The silage base shall be impervious and provided with suitable slopes and properly fitted interceptor channels to contain silage effluent and to convey it to watertight storage tank/s.
 - (iii) Prior to silage making *each year* all structures that come into contact with silage effluent shall be checked and if necessary repaired to ensure that they are leakproof.
 - (iv) A two pipe diversion system for storm water and silage effluent shall **not** be installed.

Reason: In the interests of Environmental protection.

2. Surface water shall be collected and disposed on site in accordance with details submitted to the Planning Authority on the 30th May 2007.

Reason: To eliminate the risk of pollution to groundwater and in the interests of public health.
